

**AMENDED ECONOMIC DEVELOPMENT  
INCOME TAX CAPITAL IMPROVEMENT PLAN  
FOR GIBSON COUNTY, INDIANA FOR 2010-2011**

**Introduction**

This document is the Capital improvement Plan (The "Plan") for Gibson County, Indiana ( The "County"). It is intended for adoption by the Gibson County Board of Commissioners (the "Commissioners") in conformance with IC 6-3.5-7.

**Plan Objectives**

IC 6-3.5-7 requires the adoption of the plan by the Commissioners before the County may receive its certified distribution of revenues from the Economic Development Tax ("EDIT"). The Plan must specify the uses for which the County proposes to use EDIT revenues.
