Gibson County Council Regular Session Meeting December 19, 2023

The Gibson County Council met in Regular Session on December 19, 2023, at 9:00 a.m. at the North Annex Meeting Room.

<u>Members Present:</u> President Jeremy Overton, Vice President, Derek McGraw, Council Members: Jeff Clark, Jay Riley, Robert Schleter, Michael Stilwell, and Hannah Whitehead Also present were Auditor Mike Watkins, 1st Deputy to Auditor, Kristy York, and 2nd Deputy to Auditor, Wendy Williams

The Council opened the meeting with the Pledge of Allegiance to the Flag.

DEPARTMENT REPORTS

Retention Bonus Payment for Public Defender's Department — Public Defender Lisa Moody requested permission from the Council to pay her Contract Attorneys a retention bonus from Fund 8893 Title IV-E Grant Funds. Public Defender Moody feels this is a good way to use this money as the money is generated based on the number of CHINS cases the County works; thus, the attorneys that work on these CHINS cases will receive a bonus. The Public Defender Board has approved this payment. The amount would be \$1600 per attorney for a total of \$6400. She also requested moving forward, that Public Defender Board permission is all that is required to make this payment.

Council Member McGraw motioned to allow this bonus this year and every year thereafter as long as the Public Defender Board approves and it never comes out of county funds, seconded by Council Member Clark. The vote was 7-0.

<u>Fund 2501 Jury Fees</u> –Judge Meade requested to use this fund to pay to have their work done in the Courtroom. This fund has a balance of \$236,940. They will be rewiring, replacing some glass in the courtroom, refinishing/repairing some old benches, installing two wheelchair areas in the front of the courtroom, and repairing some old tables.

Council Member McGraw motioned to approve expenditures not to exceed \$10,000 from this fund, seconded by Council Member Stilwell. The vote was 7-0.

<u>New Probation Hire and Salary</u> –Judge Meade requested a new hire for a Probation Officer. He will also need to replace a court reporter and hire a new court reporter; all of which are within the budget. The council had no issues on this.

The current court reporter will be moving to a probation officer, and the years of experience will add money to the salary. This salary change will be made in January; this salary is set by the State.

Approval of Minutes - November 14, 2023, minutes were approved as written.

Treasurer / Clerk Report – reports were acknowledged by the Council.

<u>Sheriff Vanoven</u> told the Council they are hiring as they have openings in communications, corrections, and deputy positions. Two new deputies went to the Academy yesterday and scored very well in their assessments.

<u>Health Department</u> – Administrator Shade gave Council their monthly reports; there were no questions. She advised about the high rate of respiratory illness. They have posted a job opening on the State's website and

will hire in January. They have some applicants for the nurse's position, but they will hire this position in January.

OLD BUSINESS

<u>Jail Project</u> —George Ballard, Owners Representative told Council they are putting a lot of steel on the project site. He explained the pod placement. Garmong will pour a concrete pad on the north end of the building; the pod will come in on a flatbed, a crane will lift them off the flatbed and lay them onto the poured pad and roll them into the steel structure. There will be enough room in the steel openings to maneuver them through to their permanent place. He says the office portion of the building is waiting on windows to be delivered and then they will begin drywalling inside this office.

NEW BUSINESS

<u>Michael Cochren</u> – Prosecutor Cochren told Council they are still renting office space; they are trying to remodel the North Annex for their future use with the services of Three I Engineer. He would like to use some of his unexpended, appropriated budget in Fund 2502 to pay this bill. He will have to make some transfers in this fund and then encumber this money. He will move any unused balance to his rental line. Council Member McGraw motioned to allow out of series transfers to rent and professional services and then encumber if needed, seconded by Council Member Riley. The vote was 7-0.

2024 Salary Schedule – The schedule was presented to the Council for approval and includes \$2 per hour across the board except for 2 people in Probation. Everyone was placed on a bi-weekly basis to avoid the 27th pay differential. EMS had a bit more increase in some areas. The schedule includes longevity pay in 2024; it will be paid in a lump sum in December from EDIT. Anyone hired after January 1, 2024 will not receive the pay in the first year, as it is an earned item. This longevity pay will be discussed every year. Council Member McGraw motioned to approve the salary schedule, seconded by Council Member Stilwell. The vote was 7-0.

<u>2024 Meeting Dates Approval</u> – Auditor Watkins presented the 2024 Council Meeting dates. They are scheduled the same as 2023 meetings; they will be the second Tuesday each month, except in December. The council would like to start budget meetings on Tuesday following the Council meeting, rather than on Wednesday.

Council Member McGraw motioned to approve the meeting schedule for 2024, seconded by Council Member Riley. The vote was 7-0.
