Gibson County Council Regular Session Minutes January 09, 2024

The Gibson County Council met in Regular Session on January 09, 2024, at 9:00 a.m. at the North Annex Meeting Room.

<u>Council Members Present:</u> Jeff Clark, Derek McGraw, Jeremy Overton, Jay Riley, Robert Schleter, Michael Stilwell, and Hannah Whitehead

Others present were Auditor Mike Watkins, 1st Deputy to Auditor, Kristy York, and 2nd Deputy to Auditor, Wendy Williams

The Council opened the meeting with the Pledge of Allegiance to the Flag.

<u>Election of 2024 Officers</u> – The officers and appointments will remain the same for 2024. Council Member Overton will remain the President and Council Member McGraw will remain the Vice President.

Acknowledgement of Clerk/Treasurer Reports - The council acknowledged these reports.

Approval of Minutes – December 19, 2023, minutes were approved as written.

DEPARTMENT REPORTS

Sheriff's Department – Sheriff Vanoven gave Council reports and told them the Jail's incarcerated December daily average was 89. Sheriff Vanoven gave the department's employment statistics. They have four open dispatcher positions, two open deputy positions, five open jailer positions, and two openings in Community Corrections. The Sheriff department did not work any fatality accidents in 2023.

OLD BUSINESS

<u>Jail Project</u> –George Ballard, Owners Representative gave Council a brief on the project and told them the project is moving along, but weather has them halted today, which is the first time since October 2022 and only the fourth time for the entire project. The roofing materials for the jail pod has been delivered. The arraignment, laundry, and telephone equipment are all being ordered. They are hoping to have the pods under roof by the end January. Council Member McGraw asked again if they were still on track to tear the old jail down. Owners Representative Ballard feels they are still on this track; otherwise, they are landlocked on this property. Council Member McGraw says they looked 50 years out on this project and felt it pertinent that this building be razed; he will ask this question at every meeting to ensure this does not change.

NEW BUSINESS

<u>Judge Krieg – Court Reporter Retiree</u> – Judge Krieg will need to hire a new employee to replace a retiring Court Reporter employee. He will need an additional appropriation of \$14,676 for this item. They will have an overlap to train a new court reporter. There will not be a reduction in wages for the new employee because the new employee is already an employee of the county.

<u>Judge Krieg – Pretrial Services Director</u> – Judge Krieg was present to request an additional appropriation amount of \$2,432 as the budget was not computed based on the Indiana Probation Officer's salary.

Council Member McGraw motioned to approve both amounts for advertisement of the additional appropriation. The total of additional requests in general for personal services will be \$17,108 with a reduction of the same from the public defender's budget. Council Member McGraw made the motion to advertise this additional appropriation, seconded by Council Member Riley. The vote was 7-0.

<u>Public Defender Moody Request a Transfer</u> – Lisa Moody will need to make a transfer from the Supplemental Fund to cover the hire of a new employee as her employee is moving to Judge Krieg's Court Reporter. She requests permission to move \$6,900 from line 31210 Trial Attorney Fees into 11300 Parttime in the amount of \$5,000; \$500 will move into 10401 FICA and \$1400 will move into 12500 Perf. Council Member McGraw made the motion to approve the transfer, seconded by Council Member Stilwell. The vote was 7-0.

<u>Judge Meade – Probation Officer</u> – Judge Meade is following up from last month and moving a current county employee into a probation officer. He will need an additional appropriation of \$13,113 as the new employee's salary is set by the state and their years of service compute into the salary, which is causing this increase. The public defender's budget will be decreased by \$2,892 and \$10,221 will be the additional appropriation request. Council Member Riley motioned to advertise the additional appropriation, seconded by Council Member McGraw. The vote was 7-0.

<u>GIS Director Replacement</u> – The GIS Director resigned on January 4, 2024. A replacement is needed; Assessor Beadle, sitting in for Surveyor Martin requests permission to hire this replacement. Council Members are okay with replacing this position in Surveyor Martin's budget.

<u>Oakland City Library Requests an Additional Appropriation</u> – Director Julie Elmore was present to request this additional appropriation from the Library's Improvement Reserve Fund in capital outlays in the amount of \$105,000. Council Member McGraw motioned to advertise this additional appropriation, seconded by Council Member Whitehead. The vote was 7-0.

Salary Schedule Amendment #1 — Wendy Williams presented the salary amendment to the Council. The amendment is simply a cleanup; there are four Communications Officers in the Sheriff's general fund salary section and three in the E911 salary section. Plus, the new bailiff was added to the Magistrate's section of the salary ordinance. Council Member Riley made the motion to approve this amendment, seconded by Council Member Schleter. The vote was 7-0.
