Purpose of Meeting - COVID 19 Phase 2 OCRA Grant in the amount of \$250,000

This is a Special Meeting concerning the Resolution of the County Commissioners of Gibson County authorizing the submission of a COVID 19 Phase 2 Program Application.

Whereas the County Commissioners of Gibson County Indiana recognize the need to stimulate growth and maintain a sound economy within its corporate limits and whereas the housing and community development act of 1974 as submitted and authorizes the Indiana Office of Community and Rural Affairs to provide grants to local units of government to distribute to small business for job retention and whereas Gibson County Indiana has conducted/will conduct public meeting prior to the submission of the application to the Indiana Office of Community and Rural Affairs in order to assess the housing and public facilities and the economic needs of its low income/moderate income residents. Now therefore be it resolved by the County Commissioners of Gibson County Indiana as follows

The President of the County Commissioners of Gibson County Indiana is authorized to
prepare and submit an application for grant funding to address the needs of the grants
funds to small businesses to retain jobs in Gibson County and execute and administer any
grant including the requisite general submission, project management, contracts and
agreements. Pursuant to the regulations of Indiana Office of Community and Rural
Affairs, United States Department of Housing and Urban Development.
