

ORDINANCE NO. 2012 - 6

ORDINANCE TO VACATE PART OF COUNTY ROAD 50-S

WHEREAS, there has been a signed Petition to Vacate Part of County Road 50 S presented to the Gibson County Commissioners to Vacate Part of 50 S more particularly described as follows:

A part of County Road 50 South lying east of the east right-of-way line of County Road 950 East and West of the west right-of-way line of Interstate 69 in Sections 11 and 14, Township 2 South, Range 9 West, Columbia Township, Gibson County, Indiana, being more particularly described as follows:

Commencing at the southwest corner of said Section 11, thence east along the south line of said section to the east right-of-way of C.R. 950 E and the point of beginning; thence continuing east along the south line of said section for approximately 1900 feet to the west right-of-way line of interstate 69.

WHEREAS, it is the desire of the Gibson County Commissioners to vacate part of Gibson County Road 50 S as described in the signed Notice for Petition;

BE IT ORDAINED BY THE COUNTY COMMISSIONERS THAT:

1. That the Petitioners, Ralph Buck Trust by Ralph Buck Trustee and Annabelle G. Buck by Annabelle G. Buck Trustee filed with the Gibson County Commissioners on the 22nd day of May, 2012, a "Notice for Petition To Vacate Part of County Road 50 S."

2. That the Petitioners, Ralph Buck Trust by Ralph Buck Trustee and Annabelle G. Buck by Annabelle G. Buck Trustee had said Notice of said Petition published in the Princeton Daily Clarion.

3. That all owners of land that abuts the property to be vacated is owned by Ralph Buck Revocable Trust and Annabelle G. Buck Revocable Trust.

4. That no objections or remonstrators appeared before the Gibson County Commissioners.

5. That the Gibson County Commissioners hereby grants the Petitioner's Petition to Vacate Part of 50 S particularly described above.

A part of County Road 50 South lying east of the east right-of-way line of County Road 950 East and West of the west right-of-way line of Interstate 69 in Sections 11 and 14, Township 2 South, Range 9 West, Columbia Township, Gibson County, Indiana, being more particularly described as follows:
